PARENT / LEGAL GUARDIAN: Please read AND sign the following VT North-South Senior Bowl Participant Behavioral Contract. **THIS CONTRACT IS IMPORTANT!** Please read it and consider it as seriously as do we! **Please remember that your son cannot participate in the Vermont North-South SENIOR BOWL Program without a signed Behavioral Contract in the possession of our VT Chapter management.**

We acknowledge that all enrolled participants must act in a manner consistent with the philosophy of the Senior Bowl. The focus of the practices and the Senior Bowl itself are on instruction, education, and good sportsmanship. As such, respect for oneself and all other players, coaches, medical staff, and supporting staff and officials is critical and essential.

Should my son violate any of the rules listed below, I expect to be asked to immediately travel to the practice site and/or agree to the withdrawal of my child from the Program and/or agree to the physical removal my child from the practice or game site. If requested, I will immediately and willingly comply and/or agree with such request. I understand that any and all inconveniences, hardships, financial and other costs incurred as a result of such action requested by the Coaching Staff of my son's team and/or Senior Bowl management are to be borne directly & entirely by me and/or my son. Neither the Vermont Chapter of the National Football Foundation & College Football Hall of Fame nor its staff will bear any responsibility nor financial or other costs.

In addition to all other possible reasons for dismissal from the Senior Bowl roster, for each of the following violations of Program Policy, "Zero Tolerance" is the standard. I will be immediately notified and will comply with a request to remove my son from the team roster and participation in all subsequent practices and the game if he violates any of the following rules:

- 1) Failure to stay with team & coaches at all times while in attendance at Senior Bowl practices & game
- 2) Possession of or smoking or other use of tobacco products.
- 3) Possession of or use of alcohol or other (non-prescribed by physician or parent) drugs of any kind.
- 4) Any behavior that the Team coaching and support staff deems a threat to my son's personal safety or to the safety or comfort of any other participating players or staff member or other citizen or guest of the high schools and colleges upon whose facilities upon which we are permitted to carry on practice and game activities.
- 5) **Any suspected, reported or recognized act of Verbal, Emotional, Psychological harassment, "hazing" or abuse** directed individually or as a group towards any individual fellow participant, group of participants or spectators
- 6) **Any suspected, reported or recognized act of Physical or Sexual harassment, "hazing" or abuse** directed individually or as a group towards any individual fellow participant, group of participants or spectators
- 7) Any attempt to willfully damage or take any fellow participants', coaching staff or spectator personal property.
- 8) Any recognized attempt to willfully damage or take any property belonging to the Host Practice Site Schools, Game Host Castleton College property or property of other involved organizations, including, but not limited to, the Vermont Chapter of the National Football Foundation and College Football Hall of Fame.
